According to the task 2.5: Selection and set-up of Scientific Reference Team of the LEB'IN project, a high level Scientific Reference Team of experts in the Health domain was set up, in order to have an external expert opinion on major project results.

The additional main purpose of setting up this independent high level expert group is to enlarge the communication scope of the LEB'IN and consequently USJ with the aim to enhance collaboration between Lebanon and Europe through the use of their current networks. Effective collaboration is greatly facilitated by the close interaction of individuals involved in R&D activities. In spite of the global communications revolution project collaboration remains first and foremost a "contact sport", involving close, sustained interaction of individual scientists and engineers from different organisations.

The LEB'IN Scientific Reference Team is constituted of 3 experts, chosen, according to a transparent selection process described below.



He helped to teach genetics and immunology and has participated in the creation of the Genetics Medical Unit at USJ and in doctoral training.

He is an Officer of Academics Palms, Knight of the Lebanese National Order of Merit, he received Rammal Price in 2006 (this price, created in the memory of the Lebanese physician Rammal Rammal (1951/91), is attributed every year for a scientific personality in any Mediterranean country who by his life and his activities gave strong and unique impetus for scientific exchanges in this region ").

His work in Tunisia and Algeria is equally important.

These works have resulted in over 160 publications in international newspapers, three books, three chapters and many international papers with acts and committees.

#### **Duration of this assignment**

You will be required to perform and complete your Expert's tasks between the dates of the signature of this appointment letter and at least one month before the end of the LEB'IN project (planned project end date: August 31, 2014). The present agreement is established for the duration of the Contract N° 294983. If for some reasons the Contract N°294983is stopped, cancelled or suspended by the European Commission, the present agreement will be respectively stopped, cancelled or suspended on the same day. ### **Cost claim**

It has to be done on the basis of the rate defined in article 91 of the Commission Regulation (EEC, Euratom, ECSC) N 610/86 of 11/12/1986 laying down rules for the implementation of certain provisions of the Financial Regulation of 21/12/1977 for the month in which the expenses were incurred.
